KP Essential Saver Dental plans benefits and costs

The Essential Saver Plan covers basic dental care such as preventive cleanings and exams, fillings, and simple extractions. This plan starts at just \$17 per member per month.

The Essential Saver Plus Plan covers the same services as the Essential Saver plan, plus major dental care for crowns, dentures, and oral surgery. This plan starts at just \$27 per member per month.
